# Canadian Two-Person Stick Curling Championship Hosting Package

#### *I....*Introduction:

Thank you for considering hosting the Canadian Two-Person Stick Curling Championship. Provided in this document are the hosting guidelines to assist you in preparing a bid and hosting a successful event. We encourage you to also read the related Canadian Two-Person Stick Curling Championship "Logistics" document.

## **II....Participant Eligibility**

- 1. Beginning with the 2026 CSCA national championship event eligibility is a combination of an **earned and open registration** up to a maximum total of 72 entries. Depending on qualification guidelines, teams will either play in the following events simultaneously:
- a) National Championship Grouping-Women's, Men's or Mixed divisions
- b) National "Challenge" Championship Grouping Women's, Men's or Mixed divisions.
- Each provincial / territorial association that holds a provincial championship is guaranteed three berths at the national championship. The provincial / territorial championship winners in their open, or women's and / or men's, and / or mixed division championships earn a berth to the championship and those berths are included in the three guaranteed berths.

The names of the team members of the provincial / territorial championship berths must be designated by March 1 (or within 3 days of the conclusion of their respective Provincial / Territorial Championships) of the championship year or they are relinquished and added to the open registration pool.

If a provincial / territorial champion in Women's ,Men or Mixed will not be attending the National Championship their Provincial Representative on the CSCA board will be asked to confirm the silver medalist, then the bronze medalist and so on until they determine the next team in line to take their place until one of those teams is confirmed as registered.

If a province or territory conducts only an "open" championship the Provincial Representative on the CSCA board will be asked to consult with the CSCA Rules & Events Director to identify the highest-ranking team per gender breakdown to represent their province / territory in the National Championship Grouping. If no team can be identified in the above instances the spot will be filled using an approved backfill process until the maximum for that division is reached.

• Provincial / Territorial board representatives are asked to confirm by October 31 each year their intention to fill each of the 3 guaranteed spots in the National Championship Grouping. After October 31 any reserved spots not confirmed will revert to the backfill process if needed, or to the National Challenge Grouping general registration pool.

## III.... Registration

Teams or their provincial Associations will pay the entry fee when registering as either Women's, Men's or Mixed entries. Teams as noted below are assured of an entry opportunity if their registration is confirmed and paid within the first 72 entries. Provincial / Territorial associations may elect to pay the guaranteed entries in advance. All entries received are time

stamped and any received beyond the 72 teams limit will be placed on a waiting list and would be fully refunded if not accepted.

a)Registration Deadlines and Qualifiers:

- The operational entry deadline is set approximately March 1 (minimum a month ahead of the event) This may be adjusted year to year based on the date of the event and approved by the CSCA Event Director.
- Provincial / Territorial championships held before March 1:
   Champion Teams or Provincial / Territorial representatives are responsible to confirm the entry and payment by or for their champions by March 1.

By March 1, a designated provincial / territorial representative must also confirm that all the prereserved spot(s) will be used. This includes ensuring that the entry fee is paid by or for the team. This should be considered a provincial responsibility, not a responsibility of the host committee or CSCA. On the fourth business day following the completion of each provincial championship ,the unused pre-reserved spots should be considered vacated and return to the general entry pool waiting list.

Provincial / Territorial championships held after March 1:
 It is desired if provinces / territories conducting a provincial / territorial championship ,would continue to pre-book in advance their assured entries which would include three(3) per Province / Territory conducting a championship (1 in each of the Women, Men and Mixed divisions

Once teams are confirmed as champions in their province / territory Provincial / /Territorial representatives are responsible to confirm the name of their champions no later than three days after conclusion of their event.

#### **Other Qualifiers**

- Additionally, the previous 2-year Canadian Champions in Women's, Men's, Mixed, where
  applicable would also be assured an entry in the National Championship Grouping. If a
  previous national champion also wins their current Provincial / Territorial Championship that
  Province or Territory may send their runner-up or bronze medalist as their Provincial / Territorial
  representative, moving down the line until the spot is filled. If none of the medal winners
  registers the spot is sent to the backfill process.
- **Reminder:** Each Canadian Champion for the past TWO seasons is guaranteed a berth in their respective national championship and **are not included** in their Province or Territorial guaranteed berths.
- Beginning in 2027 the National Challenge Champions from each previous year will take a spot in the National Championship Grouping with a one year exemption.

- Host Committee Chair and CSCA Rules & Events liaison to coordinate with online entry system provider to determine if there is a more suitable way to deal with guaranteed entries.
- Provinces / territories that do not hold a championship of any kind are allocated one
  reserved berth in the National "Challenge" Championship Grouping that is filled on a first
  reserved basis. After October 31 any reserved spots not confirmed will revert to the
  general registration pool.
- Registration is then open to teams from any geographical area in Canada on a first reserved basis beginning November 1st.

## National "Challenge" Championship:

- The National "Challenge" Championship (Direct entry) Grouping will play at the same time as the National Championships competing in a Mixed, Women's and Men's division breakdown. If the minimum number of entries (5) to any of the Women's, Men's, or Mixed divisions in the "Challenge" Championship the teams will be moved to the National Championship Grouping and participate there during the Championships.
- Provide banners and medals for all divisions in both Groupings
- Initially set maximum entries (12 per division in the National Championship & combined 36 entries in the National "Challenge" Championship across all divisions) to maintain the need for 8 sheets of ice to conduct the championships.
- Establish "waiting list" protocol for National "Challenge" Championship Grouping in direct entry system
- Allow divisions in the National "Challenge" Championship to expand or contract the 12 entries
  in each to maximize the 72 entries desired. Also allow a National "Challenge" division that is less
  than the minimum number of entries to be moved to compete in the National Championship
  Grouping after consultation with the CSCA Director of Rules & Events.
- 2. To clarify: If the CSCA national championship event is held in early April 20X2 then:
  - a. Provincial /Territorial champions must be declared by **March 1, 20X2** or within 3 days of conclusion of their Provincial / Territorial Championships
  - b. Remaining Provincial / Territorial berths deadline is October 31, 20X1
  - c. Open registration starts November 1, 20X1

#### **III....Minimum Number of Ice Sheets**

- 1. CSCA national championship event will require a minimum of eight (8) sheets of ice but no maximum number of ice sheets is specified. The rule of thumb is that an ice sheet is required for every nine (9) teams registered. The ice sheets can be available in one club or from a combination of two (2) or more clubs. The primary bid club is responsible for the availability of ice sheets and their ice maintenance quality.
- 2. All curling facilities must be wheelchair accessible.

# IV....Championship dates / Length

The CSCA national championship event will be held as close to the first two weeks of April as possible. The minimum event length required is four (4) days.

#### V....Host Committee

- 1. There must be a host committee with an overall championship chair who is accountable for the efficient operations in key areas such as facilities, ice and stone maintenance, registration, fundraising, draw creation, live scoring, food & beverage, opening and closing ceremonies, officiating, etc. The host committee commits to liaising with the CSCA tournament chair on a timely basis about tournament preparation progress.
- 2. As this is a national championship it is important that the host committee ensure that there is adequate accommodation space within a reasonable distance of the hosting rink(s). The host committee will arrange for adequate accommodations and communicate the accommodation options to the CSCA and championship participants.

## VI....Championship Rules

- 1. The host committee will follow the CSCA rules as set out on the CSCA website for championship play.
- 2. Please also refer to the related Canadian Two-Person Stick Curling Championship Logistics document

# VII....Entry Fees

- 1. The Entry Fee should be determined in consultation between the CSCA Championship Committee Chair and the host club tournament committee. The host club tournament committee should consider past Entry Fees, the financial report from the prior host committees and any budgeting factors specific to their hosting effort in determining the planned Entry Fee. Any subsequent amendment request to the Entry Fee must be approved by the CSCA after consultation with the host club tournament committee.
  - a. In collecting the entry fee from each team, the host committee will be asked to collect an additional competitor fee from each competitor in the championship the total amount to be submitted to the CSCA as a direct contribution to the costs involved with event prizing (crests, medals, banners). The amount will be determined by the CSCA.

## VIII....Revenue Distribution

- 1. The host club shall retain:
  - a. all registration proceeds generated from this championship event.
  - b. all proceeds generated from fundraising activities undertaken by the club in conjunction with this championship event.
    - The Host will revenue share advertising/sponsorship (90% host / 10% CSCA but such sponsorship shall not conflict with the CSCA's title/presenting sponsors.
       This would not apply to local government grants.

## 2. The host club will provide at their cost:

b. Prize payouts in a total amount that equates to 25% of the team entry fees.	Payouts should be made to each team that qualifies to move beyond round robin play into playoffs The amount of each payout is the purview of the host club, in consultation with the CSCA Championship Committee, and subject to approval by the CSCA Executive, but they must ensure that the payouts are equal in each division.

e) In-ice space, for the entire curling year, for two (2) CSCA sponsor logos at the hog line and two (2) CSCA logos at the near end hacks.	Specifically, this means logos on minimum of two sheets of ice in each 4 sheet club involved in hosting the event, or on four sheets in an 8 sheet club hosting the event.
f) . Food and beverage facilities throughout the event
